Please note the points below:

- Read the "how to apply" steps in the kit carefully
- The original signed consent orders must be lodged together with two copies certified as true copies of the consent orders
- All parties, including the independent children’s lawyer (if any) must sign each page of the consent orders – if more than 2 parties, add signing clauses for additional parties
- The details required on the covering sheets are enclosed in brackets eg <information>
- Forms must be printed single sided for filing
